### Application for Renewal of Designation as a Certified Reinsurer

Underwriters at Lloyd's, London has applied for renewal of its designation as a certified reinsurer in this Commonwealth. The application was received on December 19, 2016, and was made pursuant to the requirements set forth under section 319.1 of The Insurance Company Law of 1921 (40 P. S. §442.1(a)) and 31 Pa. Code § 161.3a (relating to requirements for certified reinsurers).
