DECISION AND ORDER

AND NOW, on this 15th day of September, 2008, Stephen J. Johnson, Deputy Insurance Commissioner of the Commonwealth of Pennsylvania (“Deputy Commissioner”), hereby makes the following Decision and Order:

Pursuant to the Insurance Holding Companies Act and in consideration of the documents, presentations, and reports received, as well as other inquiries and studies as permitted by law, the Deputy Commissioner hereby makes the following findings of fact:

FINDINGS OF FACT

Identity of Parties

1. Bankers Independent Insurance Company (“Bankers”) is a stock casualty insurance company organized pursuant to the laws of the Commonwealth of Pennsylvania with its principal place of business located in Conshohocken, Pennsylvania.
2. Maryland Diversified Corporation (“Maryland Diversified”) is a business corporation organized pursuant to the laws of the state of Maryland with its principal place of

business located in New York, New York. Maryland Diversified directly holds 100% of the issued and outstanding capital stock of Bankers.

3. American Independent Insurance Company (“AIIC”) is a stock casualty insurance company organized pursuant to the laws of the Commonwealth of Pennsylvania with its principal place of business located in Conshohocken, Pennsylvania. AIIC directly holds 100% of the issued and outstanding capital stock of Maryland Diversified.
4. American Independent Companies, Inc. (“AIC”) is a business corporation organized pursuant to the laws of the state of Delaware with its principal place of business located in New York, New York. AIC controls 100% of the issued and outstanding capital stock of AIIC.
5. Independent Insurance Investments, Inc. (“Independent Insurance”) is a business corporation organized pursuant to the laws of the state of Delaware with its principal place of business located in New York, New York. Independent Insurance controls 100% of the issued and outstanding capital stock of AIC.
6. James Carl Comis III (“Comis”) is an individual whose principal place of business is located in New York, New York.
7. William McComb Dunwoody (“Dunwoody”) is an individual whose principal place of business is located in New York, New York.
8. Comis and Dunwoody (collectively referred to as “Controlling Parties”) are the only ultimate controlling persons of Bankers.

Filing of the Request

9. On July 17, 2008, the Pennsylvania Insurance Department (“Department”) received an initial request (which together with all material received subsequently is collectively referenced as “Request”) from AIIC for approval to acquire direct control of Bankers.
10. The Insurance Holding Companies Act, Article XIV of the Insurance Company Law of 1921, Act of May 17, 1921, P.L. 682, as amended, 40 P.S. §§991.1401 et seq. (“Insurance Holding Companies Act”), provides that all changes in control of a domestic insurer must be filed with the Department for approval or disapproval.
11. Section 1402(g) of the Insurance Holding Companies Act provides for the exemption from the requirements of Section 1402(b) if the transaction:
 - a) does not have the effect of changing or influencing the control of a domestic insurer, or
 - b) is otherwise not comprehended within the purposes of the section.

12. The Request was filed pursuant to Section 1402(g) of the Insurance Holding Companies Act.

The Transaction

13. As described in the Request, AIIC would directly acquire 100% of the capital stock of Bankers.
14. As described in the Request, Bankers would remain an indirect wholly-owned subsidiary of Independent Insurance following the transaction.
15. As described in the Request, Controlling Parties would remain the only ultimate controlling persons of Bankers following the transaction.
16. The Deputy Commissioner finds that the transaction described in the Request does not have the effect of changing or influencing the control of a domestic insurer.
17. If any of the above Findings of Fact are determined to be Conclusions of Law, they shall be incorporated in the Conclusions of Law as if fully set forth therein.

CONCLUSIONS OF LAW

1. Under Section 1402 of the Insurance Holding Companies Act, the Department has jurisdiction to review and approve the acquisition of controlling securities of a domestic insurer if, after consummation thereof, the acquiring person would be in control of the domestic insurer.
2. The Request was properly filed pursuant to and in accordance with Section 1402(g) of the Insurance Holding Companies Act.
3. The restructuring of the holding company system proposed in the Request is not being contemplated to change or influence the ultimate control of Bankers, and, therefore, is exempt from the requirements of Section 1402(b) of the Insurance Holding Companies Act.
4. If any of the above Conclusions of Law are determined to be Findings of Fact, they shall be incorporated in the Findings of Fact as if fully set forth therein.
