**APPLICATION TO RE-OPEN PROCEEDINGS PURSUANT TO 40 P.S. § 221.49  
AND FOR ADDITIONAL DISTRIBUTION AND DISCHARGE**

NOW comes Teresa D. Miller, Insurance Commissioner of the Commonwealth of Pennsylvania, and respectfully requests this Court to reopen the liquidation proceeding captioned In Re: PHICO Insurance Company, In Liquidation No. 1 PHI 2001 for the limited purpose of approving the distribution of additional assets to policyholders who received prior distributions from the PHICO Insurance Company estate and to permit a scope of service to efficiently and effectively accomplish the distribution. In support of this Application, the Insurance Commissioner avers as follows:

**Motion to Reopen Proceedings Pursuant to 40 P.S. § 221.49.**

1. On January 22, 2014, this Court entered an Order approving the Final Accounting and Application for Final Distribution and Discharge of the Insurance Commissioner as Statutory

Liquidator of PHICO Insurance Company (In Liquidation) (“PHICO”)<sup>1</sup>. A copy of the Order is attached as Exhibit A.

2. The January 22, 2014 Order, *inter alia*, approved the distribution of the assets of the PHICO estate, discharged the Liquidator and released him from any liability to make payment of any further claims. The Order also provided that “any assets of PHICO Insurance Company (In Liquidation) received after the date of discharge are to be used to satisfy unreimbursed administrative expenses incurred by the Liquidator”. See Exhibit A, at paragraph 5.<sup>2</sup>

3. In February 2017, the Office of Liquidations, Rehabilitations and Special Funds of the Pennsylvania Insurance Department received \$2,267,467.71 from the North Carolina Insurance Guaranty Association (“NCIGA”). These monies were a portion of the special deposit that PHICO had provided to the North Carolina Insurance Department prior to liquidation in order to be eligible to write business in North Carolina. The NCIGA had been holding the aforementioned portion of the special deposit monies pursuant to a December 14, 2010 order from the North Carolina County of Wake Superior Court to potentially pay certain contingent claims of PHICO policyholders who resided in North Carolina.

<sup>2</sup>After the issuance of the January 22, 2014 Order, a March 14, 2014 Order was issued that caused a Rule to Show Cause (“RTSC”) to be issued on certain objectors to the Liquidator’s Application to Dismiss Objections to the Final Accounting and Application for Distribution and Discharge that was filed in November 2013. This Court then issued an Order March 17, 2014 that stayed the January 22, 2014 Order. Subsequently, the Court issued orders on April 4, 16, 17, and 22, 2014, which disposed of various filings from the aforementioned objectors. By order dated April 16, 2014, the Court issued an order that lifted the March 14, 2014 Order that had stayed the January 22, 2014 Order that approved the Final Accounting and Application for Final Distribution and Discharge. Two objectors attempted to appeal to the PA Supreme Court, but failed to perfect their appeals, which led to closure letters dated June 6, 2014 and July 21, 2014. Copies of all the Orders, other than the January 22, 2014 Order attached hereto as Exhibit A, and the two closure letters from the PA Supreme Court, are attached hereto as Exhibit B.

4. Because it would not be known whether the special deposit monies would be realized by the PHICO estate until a statute of limitations applicable to the potential contingent claims in North Carolina passed in September 2016, the Liquidator decided to proceed with seeking this Court's approval of the final distribution of the PHICO estate's assets in 2013 in order to avoid an undue delay in making a final distribution to PHICO's many policyholders who were waiting to receive their money.<sup>3</sup> Moreover, all other known assets worthy of pursuit had been collected by the time the Liquidator filed the application for final distribution and discharge in July 2013, including the balance of the North Carolina special deposit monies.<sup>4</sup>

5. In addition to the special deposit monies mentioned in paragraph 3, in April 2017 the Liquidator received funds totaling \$118,604.72 from a bankruptcy proceeding. After paying a finder's fee of 20%, this amount totals \$94,883.78. Unlike the special deposit monies, the Liquidator was unaware that these funds could potentially be realized by the PHICO estate at the time the Liquidator sought to receive this Court's approval of a final distribution and discharge in July 2013.

6. Finally, the Liquidator has \$275,000 in post discharge miscellaneous funds that she proposes be included in this additional distribution that are a combination of unclaimed property monies, returns from various state guaranty associations on pre-liquidation claims, and unused monies that had been set aside to pay the administrative costs associated with making the final distribution in 2014.

7. At the present time, there are no unreimbursed administrative expenses relating to the PHICO estate and no additional assets are anticipated to be received.

8. In light of the present circumstances, the Insurance Commissioner, through the Insurance Department's Office of Liquidations, Rehabilitations and Special Funds, proposes to reopen the PHICO proceedings for the limited purpose of distributing the amounts described in paragraphs 3, 5 and 6 for the benefit of the policyholders who previously received distributions from the PHICO estate.

#### **Proposed Distribution**

9. The final distribution of the PHICO estate, as approved by this Court's January 22, 2014 Order, paid 100% of the class "a" claims (administrative expenses) and approximately 61% of the class "b" claims (policyholders) that had values greater than zero.<sup>5</sup>

10. The proposed distribution would pay an additional distribution of at least .27% to class "b" claimants that had a final distribution amount greater than zero.<sup>6</sup>

#### **Service Requirements**

11. The priority class and final distribution amount of all the claims in the PHICO estate had been finalized without any pending objections when the Liquidator filed the Final Accounting and Application to Approve the Final Distribution and Discharge in July 2013, which was approved and confirmed by this Court's January 22, 2014 Order.

12. Pursuant to the liquidation statute, all claims in a class must be paid in full prior to paying claims in a succeeding class. See 40 P.S. § 221.44. The distribution proposed in this Application will not allow for all class "b" claims to be paid in full.

13. Because the priority class and final distribution amounts of all claims has been finally determined and 40 P.S. § 221.44 requires that all claims in a class be paid in full before

paying claims in a succeeding class, the distribution proposed in this Application will only affect claimants assigned to priority class "b" whose final approved claim value was greater than zero. Accordingly, the Liquidator proposes that she be required to provide notice only to those claimants who will be affected by this Application, as the anticipated expenses of providing notice and administrative services to all of the claimants in the estate, including the cost of mailing notice, handling returned service and responding to inquiries, cannot benefit the claimants of the estate who have class (b) claims with final approved values of zero, or, are in a priority class lower than class "b". By way of example, in class "b" alone, there are 16,280 claimants, only 1,053 of which have a claim with a final approved value greater than zero.

14. The class "b" claimants that would receive the proposed distribution and the amounts to be distributed to each claimant are listed on Exhibit C, which is attached hereto.

15. The Insurance Commissioner proposes sending a Notice of Further Distribution by first class mail to all the claimants listed on Exhibit C.

16. The proposed Notice of Further Distribution is attached hereto as Exhibit D.


17. If the Court believes that notice to all of the claimants of class "b" or of the estate is necessary, the Liquidator requests the Court to order the additional notice to be given by publication in a newspaper of general circulation in the Commonwealth.

WHEREFORE, the Liquidator respectfully requests the Court to approve the proposed distribution and enter the Order attached hereto which provides that:

1. The Insurance Commissioner's Application to re-open the proceedings at Docket No. 1 PHI 2001 for the limited purpose of making the proposed distribution of at least .27% to class "b" claimants that had a final distribution amount greater than zero is approved;

2. The proposed service of the Notice of Further Distribution is approved and shall be sent by first class mail to the class (b) claimants that are eligible to participate in this distribution, as listed on Exhibit C attached hereto;
3. The form of the Notice of Further Distribution attached as Exhibit D is approved;
4. The Insurance Commissioner is released from any liability to pay any further claims; and,
5. In all other respects, the provisions of the Order of January 22, 2014, attached to this Application as Exhibit "A", shall remain in place.

MEMORANDUM and ORDER

AND NOW, this 22nd day of January, 2014, upon consideration of the Application to Approve Final Accounting and Application for Final Distribution and Discharge filed by Michael F. Consedine, in his official capacity as Insurance Commissioner of the Commonwealth of Pennsylvania, as Statutory Liquidator of PHICO Insurance Company (Liquidator), it is ordered that:

1. The objections of Objectors, Walter Haynes, Kathleen Tomaro, Harold Henderson, Stanley Skoczlas, Shelly Vaughn, Willie Jeffries, and Maria Jurena to the Final Accounting and Application for Final Distribution and Discharge are dismissed. The Objectors, with the exception of Maria Jurena, failed to comply with this court's November 18, 2013, order. Nonetheless, considering all responses as compliant with this court's November 18, 2013, order, Objectors' objections, which revisit underlying claims that were formally concluded, are dismissed for failure to present any factual or legal basis upon which the objections could be pursued;
  
2. The Final Accounting and Application for Final Distribution and Discharge is approved and confirmed absolutely;

3. The Liquidator is authorized to make distribution of the assets of the PHICO Insurance Company in accordance with paragraph 6 of the Final Accounting and Application for Final Distribution and Discharge as follows:

- A. Priority class "a" claims will be paid at 100%. The Liquidator has already received \$77,619,562 in administrative expenses.
- B. Priority class "b" claims will be paid at 60%.
- C. There are no priority class "c" claims.
- D. There are no priority class "d" claims.
- E. Priority class "e" claims will not be paid.
- F. Priority class "f" claims will not be paid.
- G. Priority class "g" claims will not be paid.
- H. There are no priority "h" claims.
- I. Priority class "i" claims will not be paid.

4. The Liquidator is authorized to destroy the records of PHICO Insurance Company (In Liquidation) other than appropriate administrative files within the Liquidator's discretion upon such time as all appeals are exhausted and decided;

5. Any assets of PHICO Insurance Company (In Liquidation) received after the date of discharge are to be used to satisfy unreimbursed administrative expenses incurred by the Liquidator;

6. Michael F. Consedine, in his official capacity as Insurance Commissioner of the Commonwealth of Pennsylvania, and his predecessors and successors in office, are discharged as Statutory Liquidator of PHICO Insurance Company (In Liquidation) and are released from any liability to make payment of any further claims.
