RE: Certified Reinsurer Renewal Application for ACE INA Overseas Insurance Company Ltd. ("AIOIC")

Dear Mr. Wiseman:

The Pennsylvania Insurance Department ("Department") has completed its review of the application referenced above, filed pursuant to 31 Pa. Code § 161.3a and dated June 26, 2020. Our review of the application has resulted in the following determinations:

- Pursuant to 31 Pa. Code § 161.3a(e)(2), the Department hereby renews AIOIC's designation as a certified reinsurer for the period January 1, 2021, through December 31, 2021.
- Pursuant to 31 Pa. Code § 161.3a(a)(3)(A), AIOIC shall, on a legal entity basis, maintain financial strength ratings from two or more rating agencies deemed acceptable by the Department.
- Pursuant to 31 Pa. Code § 161.3a(a)(3)(ii) the rating hereby assigned to AIOIC Secure – 2/10%.
- Pursuant to 31 Pa. Code § 161.3a(a)(5) AIOIC has agreed to meet applicable information filing requirements on an ongoing basis, including complying with any other requirements deemed necessary for continued certification by the Department.

AIOIC has confirmed that it is not seeking to passport the certification requested from Pennsylvania to other states. Accordingly, AIOIC's renewal application has not been reviewed by the NAIC Reinsurance Financial Analysis (E) Working Group ("ReFAWG") for passporting purposes. Please note, therefore, that the approval granted herein for AIOIC to act as a certified reinsurer applies only to insurers domiciled in Pennsylvania.

All future renewal applications should be submitted prior to July 1 to allow for adequate review and processing time for a January 1 effective date.
