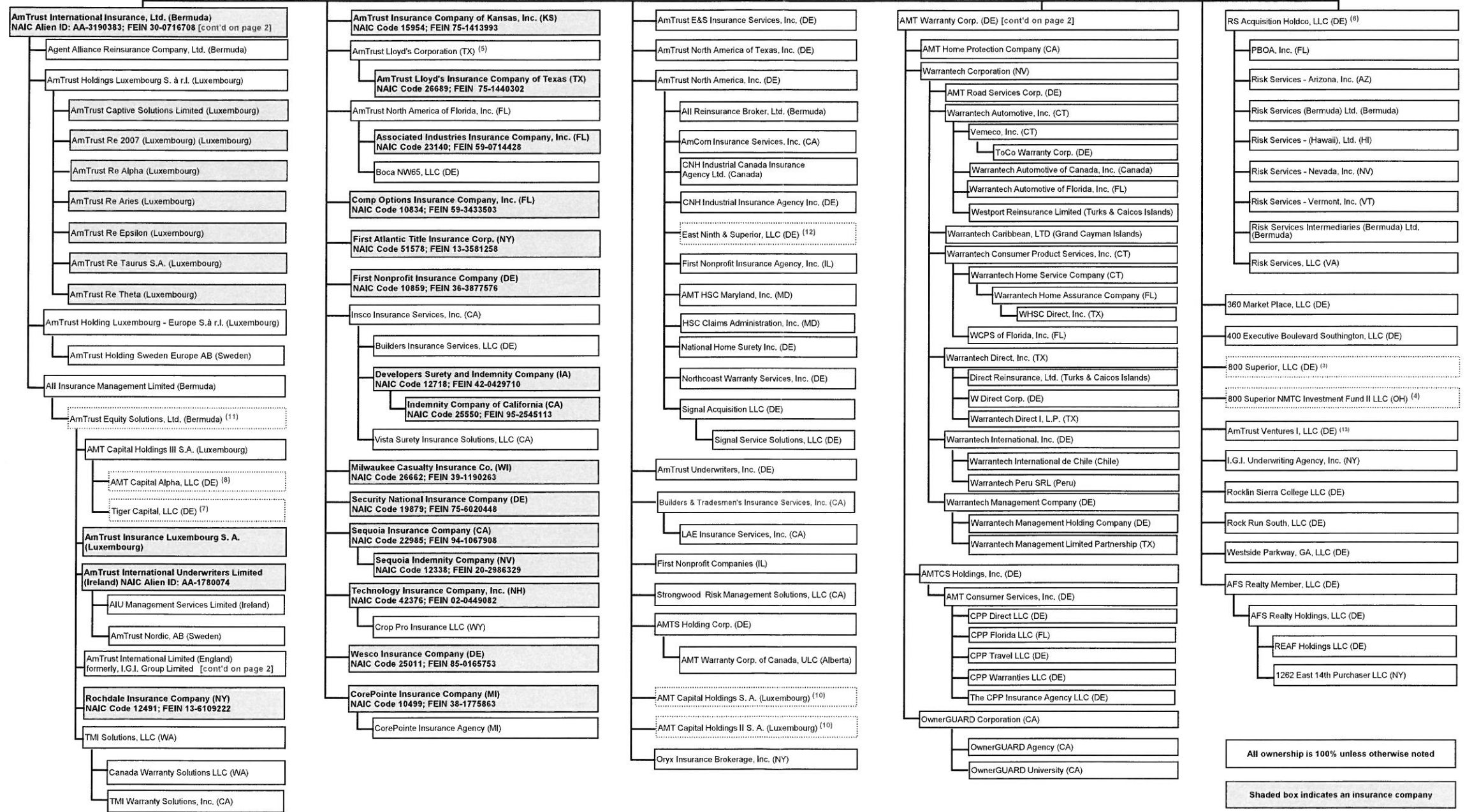

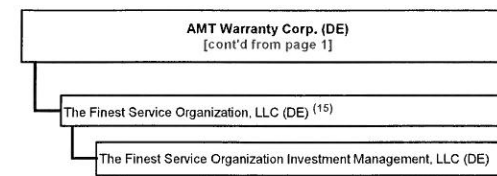
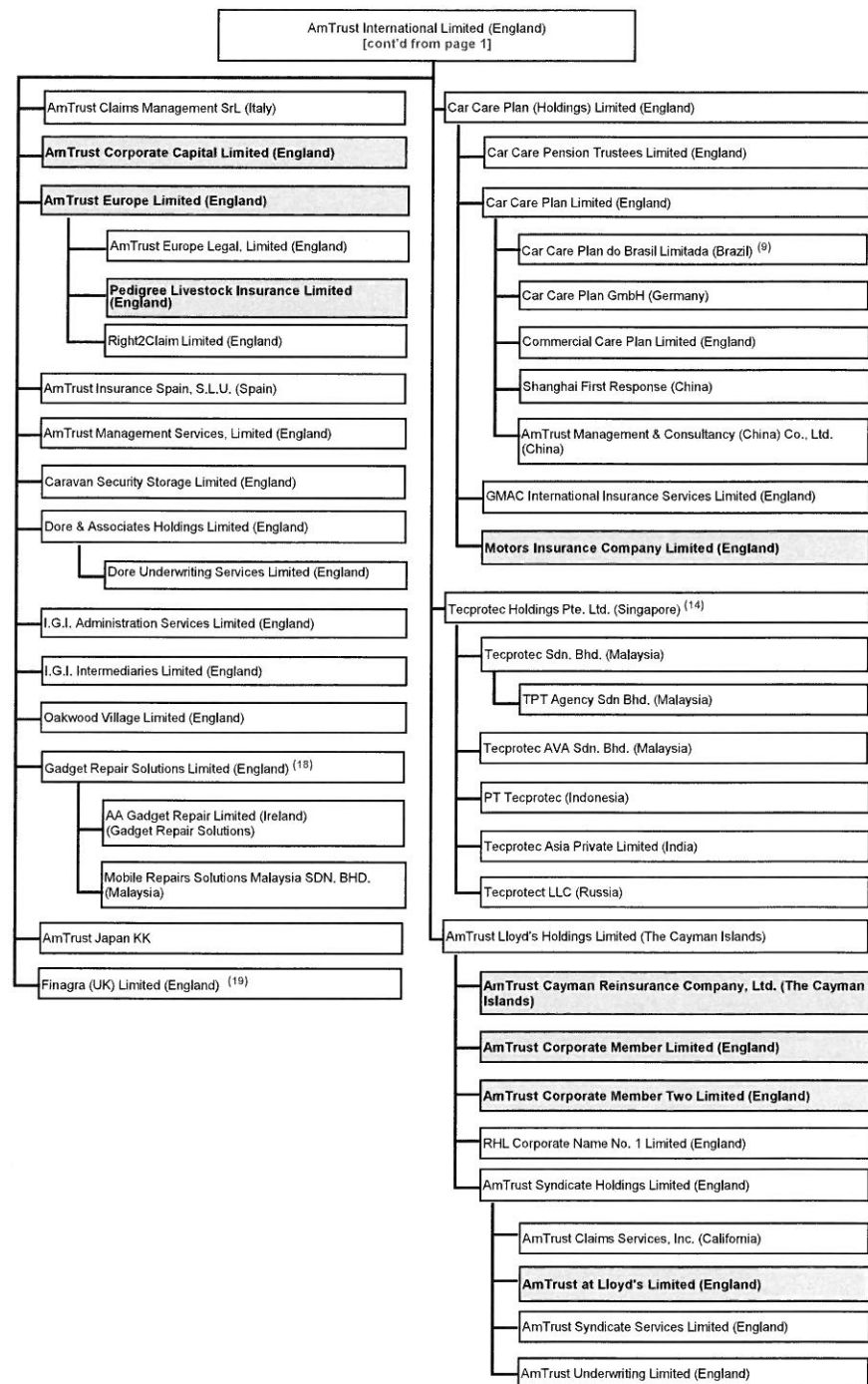

- (1) Shares are controlled, but may be held indirectly, as follows:
- Leah Karfunkel controls shares owned by the Michael Karfunkel 2005 Grantor Retained Annuity Trust ("GRAT") or ACP Re Ltd., one of the trust's assets;
  - Michael Karfunkel owns shares directly;
  - George Karfunkel owns and controls shares directly and indirectly, and controls shares owned by the Chesed Foundation of America; and
  - Barry Zyskind owns and controls shares directly and indirectly, and controls shares owned by the Teferes Foundation.
- Barry Zyskind, Michael Karfunkel, George Karfunkel, and Leah Karfunkel have publicly filed with the Securities and Exchange Commission a notice on Schedule 13D that they are acting as a group with respect to the common stock of AmTrust Financial Services, Inc. that each person controls.
- (2) AmTrust Financial Services, Inc. ("AmTrust") is a publicly-traded company listed on the NASDAQ global exchange under the ticker symbol "AFSI". Unless indicated otherwise, AmTrust owns 100% of the common stock of all direct subsidiaries.
- (3) AmTrust and Integon National Insurance Company each own 50%.
- (4) AmTrust and National General Holdings Corp. are each a 24.5% member.
- (5) AmTrust Lloyd's Corporation is Attorney-in-Fact for AmTrust Lloyd's Insurance Company of Texas.
- (6) AmTrust owns 80% (Class A Voting Interest) and Michael Rogers owns 20% (Class B Non-Voting Interest).
- (7) AMT Capital Holdings III S.A. and American Capital Acquisition Investments S.A. each own 50% Class A Interests.
- (8) AMT Capital Holdings III S.A. and American Capital Acquisition Investments S.A. each own 50%.
- (9) Car Care Plan Limited owns 99.9% and I.G.I. Group Limited owns 0.1%.
- (10) AmTrust and American Capital Acquisition Investments S.A. each own 50%.
- (11) All Insurance Management Limited and All Reinsurance Broker Ltd. each own 50%.
- (12) AmTrust North America, Inc. and National General Holdings Corp. each own 50%.
- (13) AmTrust owns 90% and David Friedburg owns 10%.
- (14) I.G.I. Group Limited owns 55% and InvestinAsia Pte. Ltd., a Singapore company, owns 45%.
- (15) AMT Warranty Corp. owns 65% and Shandon LLC owns the remaining 35%.
- (16) AmTrust International Insurance, Ltd. owns 13.2% of the entity's outstanding common stock. Michael Karfunkel, individually, and the GRAT, together, own 48.8% of the outstanding common stock.
- (17) AmTrust's principal shareholders, Michael Karfunkel, Leah Karfunkel (the wife of Michael Karfunkel and sole trustee of the GRAT), George Karfunkel and Barry Zyskind own or control approximately 6.2%, 7.6%, 9.4% and 5.1%, respectively, of the issued and outstanding capital stock of Maiden Holdings, Ltd.
- (18) AmTrust International Limited, formerly, I.G.I. Group Limited, owns 75%, and certain continuing shareholders own a total of 25%.
