On behalf of Cigna Corporation ("Cigna") and Halfmoon Parent, Inc. (together with Cigna, the "Applicants"), please find enclosed one original and one copy of a Form A Statement Regarding the Acquisition of Control of or Merger with a Domestic Insurer (the "Form A") seeking approval of the Applicants' proposed acquisition of control of Medco Containment Life Insurance Company, a Pennsylvania domestic insurance company (the "Domestic Insurer"). The Applicants request that: (i) the redacted portions of the biographical affidavits filed as Exhibit F-2 and all information in Exhibits G-1, H, K, L and M be afforded confidential treatment; (ii) the Applicants be notified in advance of any proposed disclosure by the Pennsylvania Insurance Department of such confidential information; and (iii) the Applicants be given a reasonable opportunity to seek a protective order or take other action to prevent or limit any such disclosure.
