I am writing on behalf of Monroeville Volunteer Fire Co. #4 and Monroeville Fire Dept. EMS agencies in Monroeville, PA - Allegheny County. I serve as the Chief for both of the aforementioned entities. I would like just a small piece of your valuable time to discuss our perspective on the potential merger between the West Penn Allegheny Health System (WPAHS) and the Highmark insurance provider.

First and foremost, we certainly were delighted to hear of this potential merger back in the spring of 2012 and recognized that it could prove very beneficial at many levels to Monroeville and surrounding Communities. This merger can bring strength and support to our Community & the many others in our region.

As you may recall, UPMC has recently built a new medical facility approximately one mile from WPAHS – Forbes Regional Hospital, so as you could imagine, competition for all aspects of health care are right in our front yard.
