Filing Summary:

CMFG Life Insurance Company (CUNA Mutual) was requesting a multi-year rate increase on form 2006-LTC-COMP(PA). They wanted a 25% increase effective 4/1/2021 and an additional 25% rate increase 1 year later.

The company was seeking an average 56.25% increase over 2 years on 908 PA policyholders.

The Department approved a single 20% increase.

Effective date of rate change: Renewals on and after 8/27/2019.

The current policies in place are not generating sufficient premium to pay future claims to policyholders. This is a common problem for a number of insurers nationwide because policyholders are keeping their policies longer than expected and are living longer than projected. As a result, policyholders are using more benefits on average than the company anticipated when the policies were originally sold. This means the company has to pay out more for benefits than it originally projected.

In making this decision, the Department considered the projected loss ratio for each block of policy forms, that is, the projected total amount of benefits paid out versus the total amount of premium collected, the reasonableness of the assumptions the company used in its projections, and the company's financial situation. The Department also considered the financial impact this rate increase would pose to consumers, the past rate increases policyholders have faced, and the availability of options to limit the rate increase by reducing benefits.

The company is offering ways for policyholders to limit the rate increase by reducing benefits. The company will let you know your options when they contact you directly about this premium increase.
