<u>REPORT REGARDING NOTICE OF LIQUIDATION ORDER</u> AND PROCEDURES FOR FILING CLAIMS

Jessica K. Altman, Insurance Commissioner of the Commonwealth of Pennsylvania, in her capacity as Statutory Liquidator ("Liquidator") of Senior American Insurance Company ("SAIC"), through undersigned counsel, respectfully offers the following:

1. By Order dated August 15, 2019, this Court placed SAIC in liquidation ("Liquidation Order") and appointed Jessica K. Altman, Insurance Commissioner of the Commonwealth of Pennsylvania, as Statutory Liquidator, in accordance with Article V of the Insurance Department Act of 1921 ("Act").¹ The effective date of the Liquidation Order is September 3, 2019.

2. In addition to the notice requirements pertaining to the entry of a liquidation order that are contained in Section 524 of the Act, paragraph 7 of the Liquidation Order directs the Liquidator to publish notice about the procedures for filing claims against the estate of SAIC.

3. Moreover, paragraph 8 of the Liquidation Order directs the Liquidator to file a report with the Court within 30 days of giving notice of the Liquidation Order, as set forth in

Section 524 of the Act, and of the procedures for filing claims, demonstrating, in reasonable detail, the date and manner notice was given.

4. On September 5, 2019, the Liquidator sent notice of the Liquidation Order by firstclass mail to all known policyholders and creditors, as well as the Insurance Commissioner in each state where SAIC did business, and a representative with the National Organization of Life and Health Insurance Guaranty Associations to facilitate notice of the Liquidation Order to the responsible individual guaranty associations.

5. The mailings referenced in paragraph 4 included, in addition to notice of the Liquidation Order, contained information about filing claims and answers to frequently asked questions.

6. The Liquidator also caused information about filing claims to be published in <u>The</u> <u>Legal Intelligencer on September 23, 2019, and <u>The Philadelphia Inquirer</u> on September 9, 2019.</u>
