CONSENT ORDER

AND NOW, this 30th day of December , 2020, this Order is hereby issued by the Insurance Department of the Commonwealth of Pennsylvania pursuant to the statutes cited above and in disposition of the matter captioned above.

1. Respondent hereby admits and acknowledges that he has received proper notice of his rights to a formal administrative hearing pursuant to the Administrative Agency Law, 2 Pa.C.S. §§ 101, <u>et seq.</u>, or other applicable law.

2. Respondent hereby waives all rights to a formal administrative hearing in this matter, and agrees that this Consent Order, and the Findings of Fact and Conclusions of Law contained herein, shall have the full force and effect of an Order duly entered in accordance with the adjudicatory procedures set forth in the Administrative Agency Law, <u>supra</u>, or other applicable law.

FINDINGS OF FACT

3. The Insurance Department finds true and correct each of the following Findings of Fact:

- (a) Respondent is John C. Custer and maintains a record of his address with the Pennsylvania Insurance Department as 589 Lovell Court, Hummelstown, PA 17036.
- (b) Respondent is, and at all times relevant hereto has been, a licensed resident producer.
- (c) Respondent failed to pay Pennsylvania state taxes from 2011 through 2016.
- (d) Respondent was notified by the Pennsylvania Department of Revenue by mail on April 25, 2019, that he was non-compliant with his tax obligations which could result in actions against his Pennsylvania Insurance Department issued license.
- (e) Respondent has liens from the Pennsylvania Department of Revenue totaling \$60,800.08 under the Court of Common Pleas of Dauphin County docket numbers 15CV3455, 17CV2148, 2018-CV-3900-NT, and 2019-CV-2606-NT, for non-compliance of his Pennsylvania tax obligations.
- (f) Respondent improperly answered "No" to the question asking if he had failed to pay state income tax or comply with any court order directing

payment of state income tax on his renewal applications in 2011, 2013, 2015, 2017, and 2019.

CONCLUSIONS OF LAW

4. In accord with the above Findings of Fact and applicable provisions of law, the Insurance Department concludes and finds the following Conclusions of Law:

- (a) Respondent is subject to the jurisdiction of the Pennsylvania Insurance
 Department.
- (b) 40 P.S. § 310.11(1) prohibits a licensee or an applicant for a license from providing incorrect, misleading, incomplete or false information to the Department in a license application.
- (c) Respondent's activities described above in paragraph 3(f) violate
 40 P.S. § 310.11(1).
- (d) 40 P.S. § 310.11(13) prohibits a licensee or an applicant from failing to pay state income tax or comply with any administrative or court order directing the payment of state income tax.
- (e) Respondent's activities described above in paragraphs 3(c) through 3(e) violate 40 P.S. § 310.11(13).
- (f) 40 P.S. § 310.11(20) prohibits a licensee or an applicant from
 demonstrating a lack of general fitness, competence or reliability sufficient
 to satisfy the Department that the licensee is worthy of licensure.

- (g) Respondent's activities described above in paragraphs 3(c) through 3(f) violate 40 P.S. § 310.11(20).
- (h) Respondent's violations of § 310.11(1), (13) and (20) are punishable by the following, under 40 P.S. § 310.91:
 - (i) suspension, revocation or refusal to issue the license;
 - (ii) imposition of a civil penalty not to exceed five thousand dollars
 (\$5,000.00) for every violation of the Act;
 - (iii) an order to cease and desist; and
 - (iv) any other conditions as the Commissioner deems appropriate.

<u>ORDER</u>

5. In accord with the above Findings of Fact and Conclusions of Law, the Insurance Department orders and Respondent consents to the following:

- (a) Respondent shall cease and desist from engaging in the activities described herein in the Findings of Fact and Conclusions of Law.
- (b) Respondent shall pay a civil penalty of One Thousand Dollars (\$1,000.00)
 to the Commonwealth of Pennsylvania. Payment of this penalty shall be
 made by certified check or money order, payable to the Commonwealth of
 Pennsylvania. Payment should be directed to the Pennsylvania Insurance
 Department, Bureau of Licensing and Enforcement, 1227 Strawberry
 Square, Harrisburg, Pennsylvania 17120. Payment may be enclosed with

(14) days after the date of the Consent Order.

- (c) As a condition to licensure, Respondent shall enter into a payment agreement within 90 days with the Pennsylvania Department of Revenue.
- (d) Respondent shall remain compliant with his business and personal income tax repayment agreement(s) with the Pennsylvania Department of Revenue.
- (e) Respondent's licenses may be immediately suspended by the Department following its investigation and determination that (i) any terms of this Order have not been complied with, or (ii) any confirmed complaint against Respondent is accurate and a statute or regulation has been violated. The Department's right to act under this section is limited to a period of five (5) years from the date of this Order.
- (f) Respondent specifically waives his right to prior notice of said suspension, but will be entitled to a hearing upon written request received by the Department no later than thirty (30) days after the date the Department mailed to Respondent by certified mail, return receipt requested, notification of said suspension, which hearing shall be scheduled for a date within sixty (60) days of the Department's receipt of Respondent's written request.

- (g) At the hearing referred to in paragraph 5(f) of this Order, Respondent shall have the burden of demonstrating that he is worthy of a license.
- (h) In the event Respondent's licenses are suspended pursuant to paragraph
 5(e) above, and Respondent either fails to request a hearing within thirty
 (30) days or at the hearing fails to demonstrate that he is worthy of a
 license, Respondent's suspended licenses shall be revoked.

6. In the event the Insurance Department finds that there has been a breach of any of the provisions of this Order, based upon the Findings of Fact and Conclusions of Law contained herein, the Department may pursue any and all legal remedies available, including but not limited to the following: The Department may enforce the provisions of this Order in an administrative action pursuant to the Administrative Agency Law, <u>supra</u>, or other relevant provisions of law; or, if applicable, the Department may enforce the provisions of this Order in any other court of law or equity having jurisdiction.

7. Alternatively, in the event the Insurance Department finds there has been a breach of any of the provisions of this Order, the Department may declare this Order to be null and void and, thereupon, reopen the entire matter for appropriate action pursuant to the Administrative Agency Law, <u>supra</u>, or other relevant provision of law.

8. In any such enforcement proceeding, Respondent may contest whether a breach of the provisions of this Order has occurred but may not contest the Findings of Fact and Conclusions of Law contained herein.

9. Respondent hereby expressly waives any relevant statute of limitations and application of the doctrine of laches for purposes of any enforcement of this Order.

10. This Order constitutes the entire agreement of the parties with respect to the matters referred to herein, and it may not be amended or modified except by an amended order signed by all the parties hereto.

11. This Order shall be final upon execution by the Insurance Department. Only the Insurance Commissioner or a duly authorized delegee is authorized to bind the Insurance Department with respect to the settlement of the alleged violations of law contained herein, and this Consent Order is not effective until executed by the Insurance Commissioner or duly authorized delegee.
