CONSENT ORDER

AND NOW, this <u>18th</u> day of <u>October</u>, <u>2021</u>, this Order is hereby issued by the Insurance Department of Commonwealth of Pennsylvania pursuant to the statutes cited above and in disposition of the matter captioned above.

1. To the extent applicable, Applicant hereby waives all rights to a formal administrative hearing in this matter, and agrees that this Consent Order, and the Findings of Fact and Conclusions of Law contained herein, shall have the full force and effect of an Order duly entered in accordance with the adjudicatory procedures set forth in the Administrative Agency Law, 2 Pa.C.S. §§ 101, et seq., or other applicable law.

FINDINGS OF FACT

2. The Insurance Department finds true and correct each of the following Findings of Fact:

- (a) Applicant is Steven C. Thompson and maintains a record of his address with the Pennsylvania Insurance Department as 3201 Dawson Street,

 Pittsburgh, Pennsylvania 15213.
- (b) Applicant does not possess a license to transact insurance as a producer in this Commonwealth.
- (c) Applicant, on July 7, 1994, pleaded guilty to Receiving Stolen Property, a felony, in the Court of Common Pleas of Allegheny County,

 Pennsylvania and was sentenced to five (5) years under the supervision of probation, and costs.
- (d) Applicant, on September 6, 1996, pleaded guilty to Receiving Stolen

 Property and Firearm Not to Be Carried Without a License, both

 felonies, in the Court of Common Pleas of Allegheny County,

 Pennsylvania and was sentenced to five (5) years under the supervision of probation, concurrent.
- (e) Applicant, on September 6, 1996, pleaded guilty to Fleeing or

 Attempting to Elude a Police Officer, a misdemeanor, in the Court of

 Common Pleas of Allegheny County, Pennsylvania, and was sentenced

 to sixty (60) months under the supervision of probation.
- (f) Applicant, on November 19, 1996, pleaded guilty to

 Manufacture/Deliver/ Possession with Intent to Distribute and Criminal

 Conspiracy Engaging, both felonies, Intentionally Posses Controlled

Substance by Person Not Regulated, a misdemeanor in the Court of
Common Pleas of Allegheny County, Pennsylvania, and was sentenced
to not less than one (1) year and one (1) day or more than two (2) years
and two (2) days imprisonment, twenty-four (24) months under the
supervision of probation consecutive to prior sentence, plus costs.

- (g) Applicant, on November 19, 1996 pleaded guilty to Criminal Conspiracy

 Engaging, a felony in the Court of Common Pleas of Allegheny County,

 Pennsylvania with no further penalty.
- (h) Applicant, on November 19, 1996 pleaded guilty to Intentionally Posses

 Controlled Substance by Person Not regulated, a Misdemeanor in the

 Court of Common Pleas of Allegheny County, Pennsylvania and was

 sentenced to no further penalty.
- (i) Applicant, on August 6, 2021, submitted an application to the Pennsylvania Insurance Department for written consent to engage in the business of insurance pursuant to 18 U.S.C. § 1033(e)(2).
- (j) Applicant answered "Yes" to the criminal history question on his initial Resident Producer application.
- (k) The activities in which Applicant desires to engage, constitutes the business of insurance within the meaning of 18 U.S.C. § 1033(e)(1)(A) and (f).

CONCLUSIONS OF LAW

- 3. In accord with the above Findings of Fact and applicable provisions of law, the Insurance Department concludes and finds the following Conclusions of Law:
 - (a) Applicant is subject to the jurisdiction of the Pennsylvania Insurance

 Department.
 - (b) 40 P.S. §310.6(a)(6), states that the Department shall issue a producer license, provided the applicant possesses the general fitness, competence and reliability sufficient to satisfy the Department that the applicant is worthy of a license.
 - (c) Applicant's activities described in paragraphs 2(c) through 2(h) would disqualify the Applicant from licensure pursuant to 40 P.S. §310.6(a)(6).
 - (d) 40 P.S. § 310.11(14) prohibits a licensee or an applicant from committing a felony or its equivalent.
 - (e) Applicant's activities described in paragraphs 2(c), 2(d), 2(f), 2(g) and 2(h) violate 40 P.S. § 310.11(14).
 - (f) 40 P.S. § 310.11(20) prohibits a licensee or an applicant from demonstrating a lack of general fitness, competence or reliability sufficient to satisfy the Department that the licensee is worthy of licensure.

- (g) Applicant's activities described in paragraphs 2(c) through 2(h) violate 40 P.S. § 310.11(20).
- (h) 18 U.S.C. § 1033(e)(2) provides that persons convicted of a felony involving dishonesty or a breach of trust may not engage in the business of insurance or participate in such business unless such person has the written consent of any insurance regulatory official authorized to regulate the insurer, which consent specifically refers to 18 U.S.C. § 1033(e)(2).
- (i) Applicant's activities described in paragraphs 2(c) and 2(d) constitute a conviction of a felony involving dishonesty or a breach of trust.
- (j) Pursuant to 18 U.S.C. § 1033(e)(2), the Commonwealth of Pennsylvania

 Insurance Department has the discretion to grant written consent

 permitting the Applicant to engage in the business of insurance.
- (k) Applicant's violations of 40 P.S. §§ 310.6(a)(6), 310.11(14) and (20) are punishable by the following, under 40 P.S. § 310.91:
 - (i) suspension, revocation or refusal to issue the license;
 - (ii) imposition of a civil penalty not to exceed five thousand dollars (\$5,000.00) for every violation of the Act;
 - (iii) an order to cease and desist; and

(iv) any other conditions as the Commissioner deems appropriate.

ORDER

- 4. In accord with the above Findings of Fact and Conclusions of Law, and as a condition of licensure, the Insurance Department orders and Applicant consents to the following:
 - (a) Applicant is granted the consent to engage in the business of insurance subject to the conditions of this Order.
 - (b) Applicant shall cease and desist from engaging in the activities described herein in the Findings of Fact and Conclusions of Law.
 - (c) Applicant shall further comply with all Pennsylvania insurance laws and regulations.
 - (d) Applicant shall engage in the business of insurance in a manner that is not reasonably likely to cause harm to the public, policyholders or the industry.
- 5. The terms of this Order shall remain in place for a period of five years and thereafter, unless and until the Department or the Commissioner terminates the Order. Nothing in this Order shall preclude the Department, the Deputy Commissioner or the Commissioner, in their sole discretion, from decreasing or lessening the restrictions contained in this Order in whole or in part while it is in effect. Any such lessening of the

restrictions contained in this Order shall be made in writing by the Department, the

Deputy Commissioner or the Commissioner. Further, Applicant shall not apply nor

otherwise seek to reduce or remove the restrictions contained in this Order for a period of
at least five years.

- 6. Following the five-year period referenced in paragraph 5, above, this Order shall continue unless and until the Department affirmatively terminates it. Nothing in this Order shall be construed as conferring upon Applicant any property right or interest as a result of receiving this conditional consent to engage in the business of insurance in accordance with the terms of this Order. Applicant expressly waives any right to assert that he is entitled to a hearing on the termination of this Order following the expiration of the five-year period referenced in paragraph 5. Should the Insurance Department or the Commissioner, terminate this Order after the five-year period referenced in paragraph 5, above, Applicant may file a new application for a written consent to engage in the business of insurance under 18 U.S.C. § 1033(e)(2).
- 7. The Department's conditional consent permitting Applicant to engage in the business of insurance, and Applicant's existing licenses, may be immediately suspended upon notice by the Department following its investigation and determination that Applicant has failed to adhere to any condition set forth in this Order or has violated an insurance statute or regulation.
- 8. Applicant shall have no right to prior notice of such a suspension, but will be entitled to a hearing upon written request received by the Department no later than thirty (30) days from the date the Department mailed to Applicant by certified mail, return receipt requested, notification of such suspension, which hearing shall be held

within sixty (60) days of the Department's receipt of Applicant's written request for a hearing.

- 9. At a hearing referred to in paragraph 8 above, Applicant shall have the burden of demonstrating that he is worthy of an insurance license and a conditional consent to engage in the business of insurance. In the event Applicant's conditional consent, and licenses are suspended pursuant to paragraph 8 above, and Applicant either fails to request a hearing within 30 days or at the hearing fails to demonstrate that he is worthy of a license, Applicant's suspended conditional consent, and licenses shall be revoked.
- of any of the provisions of this Order, based upon the Findings of Fact and Conclusions of Law contained herein, the Department may pursue any and all legal remedies available, including but not limited to the following: the Department may enforce the provisions of this Order in an administrative action pursuant to the Administrative Agency Law, supra, or other relevant provisions of law; or, if applicable, the Department may enforce the provisions of this Order in any other court of law or equity having jurisdiction.
- a breach of any of the provisions of this Order, the Department may declare this Order to be null and void and, thereupon, reopen the entire matter for appropriate action pursuant to the Administrative Agency Law, <u>supra</u>, or other relevant provision of law.

12. In any such enforcement proceeding, Applicant may contest whether a breach of the provisions of this Order has occurred but may not contest the Findings of Fact and Conclusions of Law contained herein.

13. Applicant hereby expressly waives any relevant statute of limitations and application of the doctrine of laches for purposes of any enforcement of this Order.

14. This Order constitutes the entire agreement of the parties with respect to the matters referred to herein, and it may not be amended or modified except by an amended order signed by all the parties hereto.

15. This Order shall be final upon execution by the Insurance Department.

Only the Insurance Commissioner or a duly authorized delegee is authorized to bind the Insurance Department with respect to the settlement of the alleged violations of law contained herein, and this Consent Order is not effective until executed by the Insurance Commissioner or duly authorized delegee.
